## Invitation to Bid for the Establishment of Ladies’ and Gents’ Dormitory (CSUCC Phase I)

1. The *Caraga State University Cabadbaran Campus* through the *Regular Agency Fund 2020* intends to apply the sum of ***Nineteen Million Three Hundred Thousand Pesos Only (P 19,300,000.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Establishment of Ladies’ and Gents’ Dormitory (CSUCC Phase I)*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Caraga State University Cabadbaran Campus* now invites bids for ***Establishment of Ladies’ and Gents’ Dormitory (CSUCC Phase I)***.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Caraga State University Cabadbaran Campus (CSUCC)* and inspect the Bidding Documents at *the BAC Office, CSUCC, Cabadbaran City*, during *Mondays to Fridays*, from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***October 15 – November 4, 2019*** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Twenty Five Thousand Pesos Only (Php 25,000.00)***. ***Upon purchase of the bidding documents, bidders must present the original copy of Mayor's Permit and a valid Government Issued ID. For bidders' authorized representatives, they must submit original copy of Special Power of Attorney (SPA) and present a valid Company ID and a government issued ID.***

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CSUCC, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Caraga State University Cabadbaran Campus* will hold a Pre-Bid Conference<sup>1</sup> on *October 22, 2019; 3:30 PM* at *Caraga State University Cabadbaran Campus Audio Visual Room* which shall be open to prospective bidders. Pursuant to GPPB Circular no. 02-2018, ***attendance to the Pre-Bid Conference is enjoined.***
7. Bids must be duly received by the BAC Secretariat at the address below on or before ***November 4, 2019, 3:30 PM***. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on ***November 4, 2019, 3:30 PM***. at *Caraga State University Cabadbaran Campus Audio Visual Room*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. *Upon submission of bids, bidders' authorized representatives shall present an original copy of authorization letter, a company ID and government issued ID.*
9. The *Caraga State University Cab adbaran Campus* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
