The CSUCC, through the IGF 2020 intends to apply the sum of One Million Nine Hundred Ninety Six Thousand Two Hundred Forty Eight Pesos and Thirty One Centavos (Php 1,996,248.31) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of ICT Equipment and Appurtenances. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

 - Duly Signed <u>Omnibus Sworn Statement</u> re: Electronic Submission of Bid Documents
 - Company ID of the owner and its designated Representative, if any; and,
 - **Government issued ID** of the owner and its designated Representative, if any.
