INVITATION TO BID FOR SUPPLY, DELIVERY AND INSTALLATION OF EQUIPMENT FOR TECHNOLOGY TRAINING AND INNOVATION LABORATORY

- 1. The CARAGA STATE UNIVERSITY CABADBARAN CAMPUS (CSUCC), through the CHED HIGHER EDUCATION DEVELOPMENT INTER AGENCY TRUST FUND 2019 BUDGET intends to apply the sum of *Ten Million Pesos Only* (Php 10,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract by lot. Bids received in excess of the ABC by lot shall be automatically rejected at bid opening.
- 2. The CSUCC now invites bids for SUPPLY, DELIVERY AND INSTALLATION OF EQUIPMENT FOR TECHNOLOGY TRAINING AND INNOVATION LABORATORY. Delivery of the Goods is required within sixty (60) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years (CY 2017 to Present) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from **CSUCC** and inspect the Bidding Documents at the address given below during **Monday to Friday** 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting August 20, 2019 September 9, 2019 before 2:00 PM from the address below upon

payment of a nun-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:

- *Ten Thousand Pesos Only (Php 10, 000.00)* for First-Time offerors
- *Three Thousand Pesos Only (Php 3,000.00)* for offerors who have participated in the previous unsuccessful public bidding.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CSUCC, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The **CSUCC** will hold a Pre-Bid Conference² on **August 27, 2019; 2:00PM** at **CSUCC Conference Room**, which shall be open to prospective bidders. Pursuant to GPPB Circular no. 02-2018, *attendance to the Pre-Bid Conference is enjoined*.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before **September 9, 2019, 2:00PM, CSUCC Audio Visual Room (AVR)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause **Error! Reference source not found.** Bids submitted beyond 2:00PM will be disqualified to join the bidding process.
- 8. Bid opening shall be on **September 9, 2019, 2:00PM, CSUCC Audio Visual Room** (**AVR**). Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 9. The **CSUCC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
