¹ A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

1. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Caraga State University Cabadbaran Campus* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on *April 2-22, 2019* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***One Thousand Pesos Only (Php 1, 000.00)***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CSUCC, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Note: Upon purchase of Bid Docs, bidders are required to present the ***original*** copy of the following:

For *Owner*: PhilGEPS Registration Certificate, Mayor’s Permit, Government Issued ID

For *Representative*: Special Power of Attorney (SPA), Company ID, and Government Issued ID

6. The *Caraga State University Cabadbaran Campus* will hold a Pre-Bid Conference² on *April 10, 2019, 9:00 A.M* at *Caraga State University Cabadbaran Campus Conference Room* which shall be open to prospective bidders. Prospective bidders are strongly enjoined to attend the pre-bid conference as per GPPB Circular 02-2018.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *April 22, 2019, 9:00 AM*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

² May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

Bid opening shall be on *April 22, 2019, 9:00 AM. at Caraga State University Cabadbaran Campus Audio Visual Room.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Caraga State University Cabadbaran Campus* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
