

CONTRACT AGREEMENT

PROCUREMENT OF VARIOUS BOOKS for CARAGA STATE UNIVERSITY CABADBARAN CITY (CSUCC)

THIS AGREEMENT made the 29 JUN 2023 day of _____ 2023 between **CARAGA STATE UNIVERSITY CABADBARAN CITY (CSUCC)** of the Philippines (hereinafter called "the Entity") of the one part, represented herein by its University President, **ROLYN C. DAGUIL, Ph.D.**, and **SUPER PAGES TRADING** of A-815 V. Rama Avenue Sitio CYP, Englis, Guadalupe, Cebu City, Philippines, (hereinafter called "the Supplier") of the other part and represented herein by its authorized representative, **CATHERINE ALCOMA**;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly, **Procurement of Various Books (IGF-2023-01-031)**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Four Hundred Forty-Seven Thousand Three Hundred Eight Pesos and 72/100 (PHP 1,447,308.72)** (hereinafter called "the Contract Price"). r

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

In consideration for the sum of **One Million Four Hundred Forty-Seven Thousand Three Hundred Eight Pesos and 72/100 (PHP 1,447,308.72)** or such other sums as may be ascertained, **SUPER PAGES TRADING** agrees to supply and deliver the books as defined in this contract within thirty (30) calendar days from receipt of Notice to Proceed at its sole cost and expense, and to fully and faithfully furnish all, services and superintendence for the implementation of this Contract in accordance with his/her/its Bid.
4. **CARAGA STATE UNIVERSITY Cabadbaran City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
